

1. PURPOSE OF THE SECURITY PROTOCOL

In order to ensure and guarantee the safety and protection of the participants, public and private property, the environment and the common heritage, as well as to prevent any type of unsafe or emergency situation that may arise during the celebration of the XIV Lifesaving European Championship Open and XXV Lifesaving European Championship Youth, this Safety Protocol has been drawn up for its implementation, to act in the event of any emergency situation as well as the prevention of possible contagion of COVID-19 during the celebration of the event.

The aim is to preserve the health of the people involved in them by minimising the risks during the course of the events in any risk situation including the transmission of COVID-19, providing a safe and healthy environment for the practice of the sport of lifesaving.


For its development, the action protocols for the return of official non-professional competitions, the regulations in force on self-protection in activities that may involve risk situations and on the organisation of public shows, the recommendations of experts, both in the field of health and aquatic prevention and safety, the criteria established by the competent authorities in these matters, as well as the elements susceptible to risk, which are most likely to occur in this type of event, have been taken into account.

2. IDENTIFICATION OF THE ACTIVITY

XIV Lifesaving European Championship Open and XXV Lifesaving European Championship Youth to be held in the Municipal Olympic Swimming Pool of Castellón (Prolongación Rio Jucar s/n) on 12, 13, 14 and 15 September from 09.00 to 13.00 and from 16.30 to 19.30 hours.



and Gurugú Beach in Castellón, on 16, 17 and 18 September from 09.00 to 13.00 hours and from 15.00 to 18.00 hours at Gurugú Beach.



3. CAPACITY

The capacity will be adjusted to the conditions stipulated by the health authorities of the Valencian Community for events of this nature, being warned periodically as these are stipulated.

The present Safety Protocol complies with the rules stipulated in the Royal Decree-Law 21/2020, of 9 June, which reflect that at no time will there be a simultaneous concentration of the athletes registered in the competition, as each heat will have a maximum of 8 or 6 athletes in individual events and a maximum of 16 athletes at each end of the pool for team events.

4. PARTICIPANTS AND STAFF

The persons attending will be those registered to take part in the competition, as well as the support staff accompanying each team, the refereeing team, the assembly team, the security team and the medical staff.

All persons (participants, team support staff, referee team, assembly team, security, medical staff,...) must be duly accredited in order to access the competition area.

5. TRAVEL AND ACCOMMODATION OF THE ORGANISING STAFF

The organising staff shall travel to the event in accordance with the recommendations issued by the health authorities at the time of the event.

Accommodation for organisers who do not live with their families will be in a single room whenever possible.

Meals will be taken in accordance with the regulations in force in the Valencian Community for catering establishments at the time of the championship, in an attempt to maintain the groups of diners established from the first day.

6. WEATHER CONDITIONS FOR THE COMPETITION TO TAKE PLACE

The races held in the indoor facility will be little affected by the weather conditions for the development of the races, being relegated to alert situations decreed by the civil protection authorities in case of adverse weather phenomena.

The extreme weather conditions for the holding of the trials in the natural aquatic area will be with sea conditions on the Beaufort scale force 7, with wind speed limits of 60 km/h (fresh sea) and 7 on the Douglas scale (rough sea/woody sea).

7. IMPLEMENTATION OF THE SAFETY PROTOCOL

The present protocol will be supervised in its application by the Safety Management of the Royal Spanish Lifesaving Federation through the Head of Medical Services of the RFESS and the Head of Covid of the RFESS and by the Head of Safety and Health Risks appointed by the Valencian Federation responsible for compliance with the rules established in the Autonomous Community of Valencia in terms of safety, emergency and prevention in emergency situations and contagion before the COVID-19.

7.1 DISSEMINATION

This Safety Protocol must be communicated, sufficiently in advance, to the persons responsible for the aquatic facility, those responsible for the natural aquatic area, work teams, collaboration, participating teams, and all those who in one way or another participate in the development of the competition, in the part that involves them or have to know, guaranteeing, in any case, its distribution to the persons responsible for the facility, the latter being responsible for its dissemination among the personnel in their charge.

By means of this Safety Protocol and in relation to the regulations in force, the participating entities are informed that they will have to appoint a person responsible for safety and health risks who will represent the entity and the athletes affiliated to it, informing them that they must comply with the Safety Plan of the aquatic facility and with this protocol in the case of the natural aquatic area in the event of emergencies of a general nature, both in the signalling, notification and collaboration procedure and in the monitoring of the emergency situation.

Similarly, by means of this Safety Protocol, athletes or, where appropriate, the persons representing them, are informed that they must follow the indications of this Protocol for

emergency situations related to the competition, as well as the indications on the prevention measures against the contagion of COVID-19.

7.2. COMMUNICATION SYSTEM FOR ATTENDEES

In the event of an emergency incident occurring in the aquatic facility in general, the persons responsible for the facility, through their Safety Plan, will be responsible for notifying those attending of the indications and procedures to be followed in relation to the declared emergency situation.

In the event of an extraordinary incident occurring in the natural aquatic area, the possibility of broadcasting messages to participants, organisers and security personnel over the event's public address system will be determined, in order to enable the resolution of the emergency situation in progress, in the most coordinated and safest way possible for all those attending.

7.3. DEALING WITH PREVENTION, INSECURITY AND EMERGENCY SITUATIONS

This table represents the organisational structure of the federation and the responsibilities in the event of situations of prevention, insecurity and emergency.

7.3.1. COVID-19 infection prevention protocols

The following indications are mandatory for the participants in the sporting event:

- Signing of a document of commitment by all those attending, regarding the acceptance of the rules established for the development of the event and especially those relating to the COVID-19, which you will find at the end of this protocol.
- Signing of a commitment document by the registering team, which you will find at the end of this protocol.
- Completion of the epidemiological form to gain access to the facility, which you will find at the end of this protocol.

7.3.1.1 In the aquatic facility: The compulsory use of masks will be determined by the requirements of the authorities of the Valencian Community at the time of the celebration of the event and which will be informed in due course.

In the event that its use is compulsory at all times, athletes may only remove it at the time of preparation, before the start, they will deposit it along with their personal clothing, in the bag or backpack that each participant must carry to the street in which he/she participates, where you should store all your belongings (including shoes and mask in their expert case).

An access control will be set up with health personnel who will measure the temperature of the participants, accompanying technical personnel, organisers' personnel and the public if their presence is authorised. Those persons who are found to have an abnormally high temperature will be invited to go to the isolation area, notifying the health authorities to carry out the relevant verification test.

- Disinfection of hands and soles of footwear for access to the installation.
- Scrupulous respect of the transit routes, from the delimited area of each team to the starting chamber, competition area and return to the team area, without the possibility of crossings.
- Essential technical, refereeing or coordination meetings shall be held in the open air, if possible, respecting, at all times, the social distancing and the recommended protective measures.
- Security and organisational personnel will comply with the established recommendations for individual protection, paying special attention to the permanent use of masks, eye protection and constant hand disinfection.
- The award ceremonies will be carried out respecting the rules in force on the date of the event, not allowing in any case personal contact between the winners and the authorities present, and always respecting the safety distance. The distances must be respected between the laureates themselves.

Area where teams stay in the sports facility:

Delimited areas should be established for each team.

If the current risk level is maintained on the date of the championship, these requirements will be established as maximum. These measures may be relaxed if the prevention situation declared by the health authorities of the Valencian Community so decrees.

- To wear a protective mask in the areas designated for each team, before and after the tests in which the persons taking part in the competition are registered.
- Place the competition material and personal equipment of the team members in their designated area.
- Take extreme precautions when changing clothes, always placing the change of clothes and belongings in the sports bag, not leaving them hanging in the common areas.
- Showering is forbidden in the facility, and must be done in your accommodation at the end of the event.

Warm-ups:

Each team must be assigned a lane and a warm-up time. There will be 5 minutes for that group to leave the pool through the transit channels established to allow access to other teams. The times will be distributed according to the warm-up time and the number of participating teams, the order being established by drawing lots.

Whenever possible, personal competition material shall be used and must be disinfected before and after each use.

Toilets, showers and changing rooms:

For the use of toilets, showers and changing rooms the following indications must be taken into account:

- Showers may not be used under any circumstances. In the changing rooms, a personal distance of 2 metres and a controlled capacity adapted to the conditions of personal distance must be maintained.
- The timetables for disinfection of the changing rooms and toilets by the cleaning staff of the facility shall be respected, interrupting traffic in these areas during their cleaning and disinfection.


Participation in swimming pool events:

At the moment of participating in any competition event, the following indications must be taken into account:

- It is compulsory to sanitise hands when entering the starting chamber.
- Whenever possible, it is recommended to use personal competition equipment, which must be disinfected before and after each use.
- Each athlete must take a bag or rucksack to the start chamber to store his or her clothing and leave it on the chair in the lane where he or she is going to participate.
- Place his mask in an envelope in his bag or rucksack just before the start.
- Collect the bag or rucksack at the end of the race, put on the mask and go to the changing room and/or the team's living area through the properly established routes
- Disinfect the chairs, the starting post and the common competition material at the end of each event.

7.3.1.2 In natural aquatic area





Area where teams stay during the event

For the assembly of temporary mobile structures, such as tents for teams and organisation, a minimum distance of 3 metres between each tent shall be taken into account.

The following points must be complied with:

- Wear a protective mask in the tents before and after the races in which they are entered in the competition.
- Place the competition material to the right of each tent facing the sea in order to maintain the organisation of the area and personal distance.
- Take extreme precautions when changing clothes, always keeping a social distance, always placing the change of clothes and belongings in the sports bag, not leaving them hanging in the common areas.
- Showering on the beach is forbidden, and must be done in your accommodation at the end of the event.
- It is forbidden to sweeten your equipment in the showers, and you must do so outside the natural aquatic area.
- No public will be allowed in the competition area in order to reduce as much as possible the capacity and the possibilities of contagion among the population.

Marshaling area:

- The marshaning area shall be set up in batteries of a small number of persons who shall maintain a minimum separation of 2 metres Between each battery a minimum distance of 5 metres shall be maintained.
- In the starting area, both in sand and water events, the hands of the lifeguards must be sanitised with disinfectant gels. In the flag event at each repetition.
- In the sand events, the lifeguards must go with a mask to the starting chamber,

and may compete without it, being very important to maintain the social distance whenever possible.

- In the flags event, the separation of the competitors will be 2 metres in order to respect the safety distance established in the protocols.
- In the water events, access to the starting chambers will be without additional clothing to that worn in the event, not leaving any personal item in the starting area or requesting its care to another person.
- In the water events, the lifeguards must access the starting chamber area with a mask, it being very important to maintain social distance. They may remove them when entering the starting line. In the case of the use of disposable masks, they must be deposited in the containers provided for this purpose and removed, following the recommendations for the use of personal protective equipment.
- At the starting line of the water events, the distance between participants shall be increased to facilitate entries into the water without risk of contact.
- It will be necessary to disinfect the competitor's competition material before entering the starting chamber area. If for club administration reasons it is not possible for each athlete to have his/her own competition equipment, a person from his/her team, wearing an identifying cap, may enter the start area transit area with the competition equipment, disinfected before its use by another athlete. Team assistants must at all times wear a mask and disinfect their hands before entering this area.
- Limitation of the presence of staff accompanying and assisting teams in the start area.
- Itineraries in the start chambers that avoid frontal crossing with other participants.

Circuits:

In water events, the heats will be carried out with a reduced number of athletes to ensure that the development of the event is safe, trying to avoid contact between participants during the course.

Limitation of the presence of personnel accompanying and assisting the teams on the courses of the event.

Finish area:

- Itineraries in the finish area that avoid crossing head-on with other participants.
- Lifesavers finishing the water events must not stop at the finish line. They must continue without stopping until the arrival chamber where they will have as many places as there are participants in the series with a separation of 2 metres between each of them, occupying the first one free.
- The lifesavers must wait in the arrival area until they are provided with their final position.
 - Maintain personal distance at all times. Once the water test has been completed, they must put their masks back on when returning to the team stay area.
 - Limitation of the presence of personnel accompanying and assisting the teams in the finish area.
- Competition equipment should, if possible, be in the possession of the athletes. If the presence of any person from the team is necessary to help in the collection of the material, he/she must wear, at all times, an identifying cap, a mask and access the area having previously disinfected his/her hands.
- Competition material must always be in the stay area of the teams, in the starting

area or at the starting line. The abandonment of competition material outside the aforementioned areas may result in sanction or disqualification for the athlete who has used it.

- The lifesavers shall remain in their lane after the finish in the sprint and sprint relay events until they are signalled to their finishing position, maintaining, at all times, the personal safety distance.
- In the flag event, after finishing the heat and taking the baton, athletes shall avoid contact with other competitors by trying to maintain a safe distance.
- In the flag event, the draw shall not be made by means of a system of exchanging cards or lane markers. The drawing of the lanes in all the Events that require it will be carried out by the refereeing team and the volunteers without contact of the athletes with any material for this purpose.
- In the flag event, at the end of the event, the athletes will leave the baton sticks punctured in the sand, where they will be directly disinfected before being repositioned for the next heat.

7.3.2.- Individual emergencies

7.3.2.1.-In the sports facility:

- In the case of an accident or isolated incident requiring assistance, the injured person shall, if possible, raise his/her arm to indicate his/her difficulty and he/she shall be evacuated.
- In the case of a minor incident, assistance shall be provided by medical personnel outside the competition area.
- If intensive care or transfer to a medical centre is necessary, the team leader shall provide the accident insurance details and the transfer medical centre to the safety director or the medical personnel in charge of the transfer.

7.3.2.2.2. General emergency in the natural aquatic area:

The person responsible for Security Management:

- He/she will contact the security personnel through the media, who, sounding horns and whistles, will indicate the cancellation of the event, indicating to the different security teams the evacuation of the participants from the natural area.
- The Regional Maritime Rescue Control will be alerted of the incidents and their evolution, requesting their collaboration if the capacity of the services present is exceeded.
- In the event of a general emergency occurring in the first part of the aquatic events, the athletes will be evacuated through the starting area. If the suspension takes place during the course of the race in an area far from the coast, the participants in the same, after the warning, will go to the nearest buoy and wait to be rescued.
- All organising and safety personnel shall ensure that no person participating in the event is left alone or lost and shall ensure that they are properly evacuated.
- All participants will ensure that the organising and security personnel have controlled their evacuation, extraction or abandonment of the competition or control area.

Organisational personnel:

Should the incident require the assistance of additional support or emergency personnel, they shall, if the incident permits, position themselves close to the incident in order to indicate to the intervening support and emergency services the exact location.

Law enforcement agencies:

- Follow the procedures set and agreed in the operational coordination area.
- Maintain order in the emergency area.
- Maintain security in the area, intervening to avoid or, where appropriate, quell possible disturbances and prevent looting.
- Communicate to the Coordination Centre any incident, information or question of importance related to the emergency.
- Cooperate with other groups or operational units in the control of the emergency.
- Activate their own resources, while the intervention of other groups or units takes place, to control the situation.
- The organisation's group of volunteers
- Support in the assistance.
- Support in different tasks

Health, rescue and life-saving personnel:

- Provide first aid and evacuate casualties.
- Follow instructions from the safety directorate, coordination centre or maritime rescue centre in the event that it is that authority that assumes control of the emergency.

7.3.3. Individual Emergency in Competition

In the event of an accident or isolated incident requiring assistance, the injured person shall, if possible, raise his or her arm to indicate his or her difficulty and the person shall be evacuated.

- In the case of a minor incident, assistance shall be provided by medical personnel outside the competition area.
- If intensive care or transfer to a medical centre is necessary, the team leader shall provide the accident insurance details and the transfer medical centre to the safety director or the medical personnel in charge of the transfer.

8. EMERGENCY MEDICAL ASSISTANCE CENTRES

In the event of an accident, the affected person will be taken to the nearest medical centre in accordance with the accident insurance taken out and compulsory for each of the participants through their federation licence.

INDIVIDUAL COMMITMENT

COVID-19 CLAUSE FOR REGISTRATION AND PARTICIPATION IN COMPETITIONS OF THE ROYAL SPANISH LIFESAVING FEDERATION

The health crisis of the COVID-19 makes it necessary to adopt a series of measures aimed at complying with the protocols established by the health authorities. The establishment and fulfilment of the aforementioned measures requires a series of commitments and forms of action on the part, fundamentally, of organisers and participants. The reading and acceptance of this document is an essential condition to take part in the competitions of the Royal Spanish Lifesaving Federation (RFESS).

The participant declares:

1.- That he/she is aware of the protocol and guidelines published by the RFESS in relation to the presence and participation in sporting events generated on the occasion of the health crisis of the COVID-19.

That he/she undertakes to comply with all the requirements or simple recommendations contained in the said protocol or guide, as well as the instructions given by the persons responsible for the competition or by personnel from the organisation present at the event in relation to the measures to avoid contagion by COVID-19.

- 3.- That he/she undertakes not to attend or take part in the event or competition in the event that he/she suffers symptoms that could be compatible with COVID-19 infection. This shall also apply to cases in which the symptoms are suffered by third parties with whom the participant has or has had contact that could objectively lead to contagion.
- 4.- That, in the event of being or having been infected by the COVID-19 virus, he/she undertakes not to attend or take part in the competition until the health authorities state that participation does not entail a risk, either for his/her person or for the rest of the participants with whom he/she may have contact.
- 5.- That, with the means at his disposal, and in any case when circumstances have arisen that make it advisable, he has undergone the existing tests to check whether he/she is or has been infected by COVID-19.
- 6.- That he/she knows, accepts and assumes that, in the current state, there is an objective risk of contagion of COVID-19 with the consequences that could arise for his/her person in terms of health or problems that could even lead to death.
- 7.- That he/she accepts that the RFESS adopts the measures indicated in the protocol and guide published by the RFESS in order to establish a reasonable safety scenario in the competition. In this regard, it is hereby stated that the RFESS, during the course of the competition, may adopt any decisions that may be necessary in relation to the establishment or application of the measures contained in its published protocol and guide, or any others whose purpose is to provide the event with a safe environment in terms of avoiding COVID-19 contagion.
- 8.- That, in the event of being infected by COVID-19, the participant exonerates the RFESS from any liability in relation to any possible damage or harm that may be caused to him/her.

- 9.- That the participant accepts that when measures or decisions are adopted by the RFESS with the aim of preserving the health of persons during the course of the competition, the essential obligations of the organiser cannot be considered to have been breached, and therefore the payment of amounts, compensation, or reimbursement of prices or amounts for registration or participation fees or costs incurred by the athlete and/or his/her club cannot be demanded.
- 10.- That the participant accepts that if he/she shows any conduct or behaviour of non-observance or non-compliance with the orders and instructions of the organising staff in relation to the safety measures to avoid contagion by COVID-19, he/she may be excluded or disqualified from the event by decision of the person in charge of the competition.
- 11.- That the participant accepts that the sporting measures set out in the previous section are understood to be without prejudice to other responsibilities that he/she may incur before the competent authorities (including the federation disciplinary bodies) as a result of conduct or behaviour of non-observance or non-compliance with the orders and instructions that are applicable, either in the sporting-federation field, or in other different fields.
- 12.- That he/she expressly authorises the personnel designated by the RFESS to take his/her temperature prior to his/her access to the facility or space where the competition is to take place, being able to deny him/her access if said temperature exceeds the maximum limit established by the competent bodies as being susceptible to being indicative of infection by COVID-19 and, in this case, to provide his/her data to the competent health authorities.

The processing described above is justified under Articles 9(2)(g) and 9(2)(h) of the GDPR, as the processing is necessary for reasons of essential public interest and as the processing is necessary for the purposes of preventive or occupational medicine.

The temperatures obtained from the measurements shall not be recorded on any kind of medium.

The Data Controller shall carry out processing in a lawful, fair, transparent, adequate, relevant, limited, accurate and up-to-date manner.

Data security is guaranteed through the adoption of technical and organisational measures that allow data integrity and the exercise of data subjects' rights.

In this regard, interested parties may exercise their rights of access, rectification, limitation of processing, deletion, portability and opposition to the processing of their personal data as well as to the consent given for the processing thereof, by sending their request to dpo@juriatis.es. The interested party is also informed of their right to file a complaint with the AEPD in the event that they believe that their rights have been violated.

Declares:

- 4.- That, in the event that any of the persons registered by the club is or has been infected by the COVID-19 virus, they undertake not to attend or take part in the competition until the health authorities state that participation does not entail a risk, either for themselves or for the rest of the participants with whom they may have contact.
- 5.- That, with the means at their disposal, and in any case when circumstances have arisen that make it advisable, the persons attending on behalf of their entity have undergone the existing tests to check if they are or have been infected by COVID-19.
- 6.- That the club knows, accepts and assumes that, in the current state, there is an objective risk of contagion of COVID-19 with the consequences that could arise for the people attending from their club in terms of health or problems that could even lead to death.
- 7.- That he/she accepts that the RFESS adopts the measures indicated in the protocol and guide published by the RFESS in order to establish a reasonable safety scenario in the competition. In this regard, it is hereby stated that the RFESS, during the course of the competition, may adopt any decisions that may be necessary in relation to the establishment or application of the measures contained in its published protocol and guide, or any others whose purpose is to provide the event with a safe environment in terms of avoiding contagion by COVID-19.

- 8.- That, in the event that any of the persons belonging to its entity were to be infected by COVID-19, the club exonerates the RFESS of any responsibility in relation to the possible damages that could be derived for their person.
- 9.- That the club accepts that when measures or decisions are adopted by the RFESS with the aim of preserving the health of persons in the course of the competition, the essential obligations of the organiser cannot be considered to have been breached, and therefore no payment of amounts, compensation, or refund of prices or amounts for registration or participation fees or costs incurred by the club and any person belonging to the same registered in the competition can be demanded.
- 10.- That the participating club accepts that if any person who has registered in the competition shows any conduct or behaviour of non-observance or non-compliance with the orders and instructions of the organising personnel in relation to the security measures to avoid contagion by COVID-19, they may be excluded or disqualified from the event by decision of the person in charge of the competition.
- 11.- That the participating club accepts that the sporting measures set out in the previous section are understood to be without prejudice to other responsibilities that the entity may incur before the competent authorities (including federation disciplinary bodies) as a consequence of conduct or behaviour of non-observance or non-compliance with the orders and instructions that are applicable, either in the sporting-federation field, or in other different fields, by any of the persons representing them in the competition.
